The following is the status of the New York State Military Emergency Boat Service

1) ADMINISTRATION:

- a. The summer NYNM NEWSLETTER has been posted to the Naval Militia website. There is a lot of information in this letter regarding changes to the promotion policy. It is a MUST-READ for those considering promotion in 2024 and beyond.
- b. BU1 Putney and ME2 Carey have been selected to attend the MPVOC in LGeorge.
- c. The NY Naval Militia has been approved to start a UAV (drone) program. The initial issues will be the procurement of equipment and the establishment of policies to govern the program. EOCS Pease is slated to come aboard MEBS for a short period to deal with several of these issues.

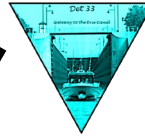
- ii. PB 400 shaft repairs complete. The vessel is FMC and back on DET 1 mission.
