8. What type supplies/cargo/and or personnel are transported? What is the weight and cube requirement for the items being transported with this vehicle?		
9. Is maintenance support available and at what level?		
10. Are repair parts available?		
11. Can presently authorized vehicle do the job and if not why not?		
12. How long is this requirement to be supported?		
13. What other similar/like vehicles are available?		
14. What vehicles will be replaced if this action is approved?		
15. What is the impact on the units mission if this action is not approved?		

16. Is this a new mission? If not, how is the mission being accomplished now?

17. Why can't a non-tactical vehicle of similar type and design do this job?

18. Can the mission be accomplished by shuttling or pooling? If not why not and what percentage must be preformed in one lift.

19. Are weapons systems required to be mounted on the vehicle?

20. What specifically requires the type, size and quantity vehicles requested?

21. Is the vehicle required for installation support? If yes, then be specific as to why a non-tactical vehicle can't do the mission.

ADDITIONAL QUESTIONS WHEN TWV'S ARE REQUIRED FOR TRAINING:

22. Are the vehicles) required for direct training or training support?

23. For direct training:

- a. List the approved Program of Instruction (POI) and description of what the students perform with/on the TWV.
- b. What is the annual student population?
- c. What is the average class size?
- d. What is the frequency of vehicles) usage: once a day, once week or once month?
- e. How many hours is the vehicle used: one, four or eight hours?
- f. What is the student to equipment ratio?
- g. Can instruction be split in shifts to maximize the use of assets? If not, why not?
- h. Are vehicles centrally pooled so they can be used by other POI that may require support? If not, why not?

24. If required for training support, what requires a tactical versus a non-tactical?

25. Is this request to identify a requirement without authorization or requirement with authorization?
