SUBJECT: Retaining a Quality Noncommissioned Officer Corps Serving in the ARNG Active Guard Reserve (AGR) Program (Title 10 and 32) (PPOM #16-028)

- 2. Applicability. This policy revises the Noncommissioned Officer (NCO) Corps' developmental timelines and ensures that NCOs with the most potential who

demonstrate the highest distinction of the attributes expected of our professional NCO Corps continue to serve and remain the "backbone" of The Army National Guard (ARNG).

- 3. This policy applies only to Soldiers serving in the ARNG AGR program. It does not apply to ARNG Soldiers serving in a traditional status (M-Day).
- 4. The following provides clarification of the updated policy.
- a. Reference 1a established new RCPs for all enlisted Soldiers serving on Active Duty, including Title 10 AGRs. To ensure RCPs are consistent for all enlisted Soldiers performing Active Service, this memorandum implements the same RCPs to the Title 32 AGR program. Accordingly, effective immediately, a Title 32 AGR Soldier may serve on Active Service up to the following RCPs (Table 1) or age 60, whichever occurs first. This includes all senior NCOs selected by the ARNG promotion board convened after the date of this memorandum. Soldiers who were 40 years of age or older on the date of their enlistment may exceed age 60 but no longer than age 62 to complete the minimum time for regular or non-regular retirement.

- b. Effective 1 October 2016, senior AGR Soldiers selected by the ARNG promotion board that convened before the date of reference 1a will have an RCP based on (Table 2) or a minimum of 12 months remaining in service, whichever is longer. The ARNG will complete this "rollback" of RCPs over a 3-year period as indicated on (Table 2).
- c. All Command Sergeants Major (CSMs) and Sergeants Major (SGMs) who serve in nominative positions are authorized to serve beyond 30 years total active service while serving in the position. A nominative position is any authorized CSM or SGM billet

where a general officer or senior executive service member rates the CSM or SGM and when the position is on a valid MTOE, TDA, or a provisional organization approved by HQDA or the ARNG. The Deputy Director, ARNG (DDARNG) must approve exceptions for operational reasons. Upon leaving a position, which authorizes service beyond 30 years, NCOs who have not applied for retirement will be classified using special reporting code 09U.

d. The ARNG AGR program does not recognize a "promotable" status.

- e. Soldiers who exceed their RCP because of reduction in grade or removal from a promotion list must retire or separate from the ARNG AGR program no earlier than 90 days, or no later than 180 days, after the effective date of their reduction in grade. Soldiers with 18 or more years of Active Federal Service who exceed their RCP because of a reduction in grade may serve to meet the minimum retirement eligibility unless the Assistant Secretary of the Army (Manpower and Reserve Affairs) approves an involuntary separation.
- 5. States and The Human Capital Management (HCM) Division will continue to manage their AGR forces through use of the Active Service Management Board (ASMB) and Release from Active Duty (REFRAD) Board respectively at the discretion of The Adjutant General and the DDARNG as applicable.
- 6. Any deviation from the stated policy, States/HCM must request an exception to policy in accordance with the references through e-Tracker as and addressed to Chief, Personnel Policy Division, at 111 South George Mason Drive, Arlington, VA 22204.
- 7. This policy remains in effect until superseded or rescinded. The Personnel Policy Division (HRH-M), G-1 will incorporate the provisions of the implementing guidance into the next revision of AR 135-18 and NGR 600-5.
